



PEF's 48th Annual Convention

Hotel Accommodations

Room blocks for this year's convention have been reserved at the following hotels: Sheraton, Wyndham Garden, DoubleTree, Holiday Inn. See "A comparison of hotels in Niagara Falls" to compare and contrast the accommodations. All accommodations are subject to the following guidelines:

- Delegates are eligible for overnight room accommodation.
- **THE REGISTRATION DEADLINE FOR HOTEL REQUESTS is Monday, August 31, 2026.**
- **OVERNIGHT RESERVATIONS ARE BASED ON DOUBLE OCCUPANCY.** Delegates who elect to share a room with another delegate during the Convention are responsible for incidentals charges only.
- **PEF Divisions are not permitted to pay for the single room supplement.**
- **PEF WILL NOT PAY FOR SINGLE ROOMS FOR DELEGATES REQUESTING MEDICAL ACCOMMODATIONS.**
- **Delegates from Region 1 may request an Opt-Out stipend in lieu of hotel accommodations.**
 - o The stipend is \$150 (\$50 per day) and covers all travel expenses (mileage, parking, tolls, and incidentals). It is intended for Region 1 delegates who choose to stay home and commute to Convention daily. Additional travel reimbursement will not be approved.
 - o Delegates who select this option will still receive the Delegate Meal Stipend of \$150 and are also eligible to receive the PEF Division Stipend (up to \$150 if their division participates).
 - o After COVID, some hotels have implemented new protocols regarding housekeeping services. Some hotel staff will not enter guest rooms to clean once the room is occupied. Towels and other amenities will be supplied as requested.

Overnight Room Options

SINGLE ROOMS

- Select this option if you DO NOT want a roommate.
- PEF will request, but cannot guarantee, rooms with a king or queen bed.
- When checking into the hotel, all delegates must provide a credit/debit card for half the room cost, which is \$90/day. A hold will be placed on your card; no exceptions will be made.

DOUBLE ROOMS WITH GUEST

- Choose this option if you are a delegate and bringing a guest who is not a delegate.
- When checking into the hotel, all delegates must provide a credit/debit card for half the room cost, which is \$90/day. A hold will be placed on your card; no exceptions will be made.

DOUBLE ROOMS (TWO BEDS)

- You must have your roommate's name and information at the time of registration or you will not be able to complete registration.
- If a delegate selects the "double room" option and does not have a roommate, then a roommate will be selected for you.
- Cancellations for a double occupancy room must be submitted to Special Events by Monday August 31, 2026. A new roommate will then be assigned by PEF to fill the vacancy.
- If a delegate chooses to have a single room after the roommate cancels, the delegate will be required to pay \$90 per day for the single room. If the delegate does not agree to pay for a single room, a roommate will be assigned by PEF.
- Upon checking into the hotel all delegates must provide a credit/debit card for incidentals. A hold will be placed on your card; no exceptions will be made.

Pets

- Rooms are assigned on a first-come, first-served basis. We will do our best to accommodate delegates traveling with pets. However, we cannot guarantee placement at specific hotels because of pet accommodation needs.
