PEF Division 179, representing the Office of General Services (OGS) and Division of Homeland Security & Emergency Services (DHSES), anticipates the award of seven (7) one time \$750 scholarships. Scholarship recipients will be based on a lottery, after verification of eligibility. Each scholarship will be awarded to a student for attendance at a 2 or 4 year college or university working toward an associate or a B.A./B.S. degree starting with the Fall 2026 Semester. Graduate students are not eligible.

Eligibility:

To be eligible for a scholarship, a parent or legal guardian of the applicant must be a member in good standing with PEF Division 179 for one year. The school must be an accredited 2 or more year college or university. Applicant must be a full time student, or have been accepted to become a full-time student, at the college/university in the Fall Semester of the year for which you are applying for the scholarship. In the interest of reaching the most Division members, only one winner per member family (multiple students in the same family can apply), and each applicant can only win one award per his/her college career. (past winners are not eligible to apply again).

How to apply:

Complete the application on the reverse side of this information sheet. Answer all questions completely. Return the application form (in PDF file) to the e-mail address printed on the application by the designated date below.

Selection:

Winners will be chosen by lottery and verified by a committee appointed by the Division Council or its officers. Two alternates will be drawn at the same time to help fulfill the commitment to our members should one of the successful candidates be disqualified.

Awards:

Scholarships will be awarded to the successful lottery winners prior to attendance at school in the year for which the scholarship is awarded. It is incumbent upon the successful candidate of the scholarship to provide acceptable **verification of enrollment**, (required for accountability in a financial audit of Division funds). Acceptable documentation may be the students' billing statement or payment receipts. Awards will be distributed upon receipt of accepted documentation. Successful candidates shall submit the required documentation by September 30, 2026 or will be disqualified and the Alternates will be the substitute award winners.
