## **MEMORANDUM**

**SUBJECT:** Geographic Pay Differentials for Registered Nurses

**DATE:** July 1, 2022

As part of the Division of Classification & Compensation's efforts to improve recruitment for registered nurses, we are pleased to announce that we have approved a Geographic Pay Differential, pursuant to Section 130.7 of the Civil Service Law, of \$35,000 for mid-Hudson and downstate areas, and \$20,000 for all other locations for the titles on the attachment. The Division of the Budget has approved these rates effective June 9, 2022, for employees on the Administrative Payroll and June 16, 2022, for those on the Institutional Payroll.

The Nursing Workgroup that we recently convened continues to explore initiatives, such as restructuring the nursing titles, to further improve recruitment.
