Other Programming Included in Final Budget:

- (1) **Roswell Park**: \$6 million reduction in capital expenses for Roswell Park (\$57 million to \$51.3 million). The operating supplement is authorized again at the 2022-23 level at \$55.4 million.
- (2) **Summer School for the Arts:** This program is funded at \$1,765,000.
- (3) **OITS Training Supplement:** The \$1.7 million represents a reduction of \$300,000 from 2022-23.
