## LEGISLATIVE UPDATES

<u>COLA BILL</u> - Sen Jackson sponsored it and is waiting for fiscal impact statement and then a bill number will be assigned. <u>Health Care Diminishment Bill</u> - awaiting a new bill number and will be removing reference to reimbursement - the law suit - lost so not an issue any longer. P. Lyons is meeting with AFLCIO who has the umbrellas of unions and is trying to craft a bill we can build coalition on with all union member that are affected. Strength in Unity. <u>Skilled Nursing bill</u> the governor vetoed it. Senator Breslin and Assemblyman McDonald are going to try to but it into the budget bills.

TREASURERS REPORT- A. Wiley- The budget for 2023-2024 was submitted along with the 4<sup>th</sup> quarter

report. BALANCE as of 2/28/23 is \$18,124.57 before this meetings expense.

**SECRETARY'S REPORT**- 191 RSVP'D to attend this meeting.

Constitutional Amendment- B. Harms- change the constitution from 6 meetings a year to up to 4 meetings a year. After much discussion it was changed to up to 6 meetings a year. A motion to accept the change was made by P. Spath, seconded, and carried.

MBP- Samantha Kalbfliesh — Sam gave a presentation on MBP benefits available to members. She was also able to talk one on one to members before and after the meeting.
