

Breakout with management went well. We have had a lot of turnovers, so the newer people didn't have a lot of perspective on issues. Feedback was generally good from management, no negative feedback, and specific comments about valuing the training were passed along. • PEF - pre-survey did not have a lot of response from management. Suggested a focus group to get a better perspective on what management wants in the next training. • Parties agreed - Need to revise case study to add more for management on their side of the process. 
